- A-2 STUDENT APPEAL: The Board heard an appeal from the parent of a middle school student in Area 3. Mr. Hazen MOVED to uphold the decision of the Tribunal and expel the student for the remainder of the 2012-2013 school year. Also included in the motion was to have the administration to evaluate the student's record for 2013-2014 placement; SECONDED by Mr. Liner; MOTION CARRIED UNANIMOUSLY.
- A-3 STUDENT APPEAL: The Board heard an appeal from the parent of a middle school student in Area 3. Mr. Hightower MOVED to allow the student to return to Center of Innovative Learning at Pinecrest on strict probation; SECONDED by Mr. Liner; MOTION carried on a vote of 6-2 (Mr. Barber and Mrs. English opposed).
- A-4 STUDENT APPEAL: The Board heard an appeal from the parent of a high school student in Area 2. Mr. Green MOVED to allow the student to attend the Center of Innovative Learning at Pinecrest on strict probation and short term assignment; SECONDED by Mr. Hightower; MOTION carried on a vote of 7-0-1 (Mr. Fleming abstained).

Also included in the motion, the Administration will evaluate course work to determine placement at home school; SECONDED by Mr. Green; MOTION failed on a vote of 3-5 (Mr. Liner, Mr. Barber, Mr. Hazen, Mr. Hightower and Mr. West opposed). Mr. Hightower MOVED to allow the student to return to regular school on strict probation; SECONDED by Mr. Hazen; MOTION CARRIED UNANIMOUSLY.

Mr. Fleming MOVED to adjourn the meeting; SECONDED by Mr. Hazen; MOTION CARRIED UNANIMOUSLY. The meeting adjourned at 9:25 p.m.
