A-1 STUDENT APPEAL: The Board an appeal from the parent of a high school student in Area 1. Mr. Barber MOVED to allow the student to attend the Center of Innovative Learning at Pinecrest on strict probation and long term assignment; SECONDED by Mr. Fleming; MOTION carried no a vote of 8-0-1 (Mr. Hightower abstained).

A-2 STUDENT APPEAL: The Board heard an appeal from the parent of a high school student in Area 1. Mr. Hazen MOVED to uphold the decision of the Tribunal and expel the student for the remainder of the 2012-2013 school year; SECONDED by Mr. Liner; MOTION carried on a vote of 7-2 (Mr. Fleming and Mrs. English opposed).

Mr. Fleming MOVED to adjourn the meeting; SECONDED by Mr. Hazen; MOTION CARRIED UNANIMOUSLY. The meeting adjourned at 7:35 p.m.
