- TIF PRESENTATION BY POPE ZEIGLER, LLC AND TOWN OF JACKSON OFFICIALS: Mr. Pope presented a detailed overview of the TIF Proposal and Redevelopment of the Town of Jackson and the impact it will have on the Aiken County School District.
