Dr. Bradley MOVED to reconsider Item C-1 COVID-19 Update – Advisory Committee Report and recommendations that were tabled earlier in the meeting; SECONDED by Mr. Silas; MOTION PASSED UNANIMOUSLY.

Ms. Rhinehart-Jackson MOVED that when students return from the Thanksgiving Holidays elementary students attend school four days a week and Middle and High School students return to the A, B, hybrid schedule until the start of the Christmas Holidays; all athletic activities cease, and that the district establish a tiered threshold system based on data provided by the CDC, SCDHEC, Aiken County Schools, and the Back To School Advisory Committee to determine which model will be used virtual, hybrid or full time face to face learning; MOTION failed for lack of a SECOND.

Ms. Rhinehart-Jackson MOVED that when students return from the Thanksgiving Holidays elementary students attend school four days a week, and Middle and High School students return to the A, B, hybrid schedule until the start of the Christmas Holidays; and that a Meeting be held at a later date to discuss the district establishing a tiered threshold system based on data provided by the CDC, SCDHEC, Aiken County Schools, and the Back To School Advisory Committee to determine which model will be used virtual, hybrid or full time face to face learning and if athletics should be postponed; SECONDED by Mr. Nuessle. Mr. Nuessle MOVED to amend motion for elementary school students to attend school five days a week upon returning from the Thanksgiving Holidays; AMENDED MOTION failed for lack of a SECOND. MOTION carried on a vote of 6-2 (Dr. Bradley and Mr. Nuessle opposed)

Ms. Rhinehart-Jackson MOVED to adjourn the meeting; SECONDED by Mr. Silas MOTION CARRIED UNANIMOUSLY. The meeting adjourned at 10:20 p.m.
