Fleming abstained). Mr. Hightower MOVED to approve the minutes of the Regular

Meeting held on May 27, 2014; SECONDED by Mr. Liner; MOTION carried on a vote of

7-0-1 (Mr. Barber abstained).

Mr. Liner MOVED to approve the Read to Succeed Literacy Coordinator;

Mr. Hightower and Mr. West opposed).

Mr. Hazen MOVED to approve one-time funding of \$250,000 for sports at all school levels and take it out of fund balance; SECONDED by Mr. Smith; Mr. Smith MOVED to amend the motion to include matching funds for Athletics for the 2015-2016 school year as indicted in the budget from the early 1990's; SECONDED by Mr. Liner; AMENDED MOTION failed on a vote of 4-4 (Mr. Barber, Mr. Green, Mr. Hightower and Mr. Fleming opposed). ORIGINAL MOTION CARRIED UNANIMOUSLY.

Mr. Green MOVED to approve the substitute teacher pay increase by \$2.00 per day; SECONDED by Mr. Liner; MOTION CARRIED UNANIMOUSLY.

Mr. Liner MOVED to approve the 1% bonus for employees at top step and teachers rising to steps 1, 2, or 3; SECONDED by Mr. Smith; MOTION carried on a vote of 7-1 (Mr. Barber opposed).

Mr. Hightower MOVED to approve one-time funding of \$100,000 for janitorial supplies (\$4 increase per student) and take it out of fund balance; SECONDED by Mr. Liner; MOTION CARRIED UNANIMOUSLY.

Mr. Smith MOVED to approve one-time funding of \$100,000 for office supplies (\$4 increase per student) and take it out of fund balance; SECONDED by Mr. Liner; MOTION CARRIED UNANIMOUSLY.
