STUDENT APPEAL: Mr. Hightower MOVED in view of the Principal's willingness to continue serving this student as a second grader, and in light of the addition interventions that have been offered from the Department of Special Programs, even though this student does not qualify under Section 504 or under IDEA, the Board voted to overturn the earlier decision of the Tribunal and allow the student to continue to be served at the school and that the student and parents cooperate with intervention efforts as may be indicated or offered, and that the student's status will be probationary and under such reasonable circumstances and conditions as the building level administration may impose, consistent with their age and understanding; SECONDED by Mr. Hazen; MOTION CARRIED UNANIMOUSLY.
- c. STUDENT APPEAL: The Board heard an appeal from the parent of a middle school student in Area 1. Mr. Hazen MOVED to uphold the decision of the Tribunal and expel the student for the remainder of the 2014-2015 school year. Also included in the motion, the administration will determine placement for 2015-2016 school year; SECONDED by Mr. Liner; MOTION CARRIED UNANIMOUSLY.
