Programs For At-Risk/Disadvantaged Students

Purpose: to establish the board's adherence to state regulations regarding district programs for at-risk/disadvantaged students.

The board is deeply concerned with the number of students who are leaving school before graduation. The board is also concerned with providing a learning environment conducive to keeping students in school. The board endorses effective programs that are designed to keep students in some form of an educational program until graduation. As resources are available, alternative educational programs, with an academic focus as well as counseling services, will be provided for students who are at risk of dropping out of school.

Short-Term Alternative School

- Approximately 20 Days
- Five sites
- Computer lab setting
- Accredited online virtual instruction with onsite proctor (Certified elementary teacher available at CIL)
- Therapeutic counseling
- Coordinated community resources
- Transition services



Long-Term Alternative School

- Center for Innovative Learning (CIL) a Pinecrest
- Structured, disciplined setting
- Available up to the remainder of the school year for all levels
- Virtual and traditional instruction
- Therapeutic counseling.
- Coordinated community resources
- Transition services



Long-Term Alternative School

- Students K-12 may come to CIL for short or long term placement from
 - Tribunal or school board recommendation
 - Audit-packet filled out by home school SIT
 - Crisis-emergency placement
 - DJJ
- Instructional Model
 - General and SPED students
 - Common Core State Standards and Aiken County
 Curriculum

Behavior Management System

- Decision Making Framework

Child Support and Services

Transition

- Student Reviews
 - Meeting for progress at approximately 4-6 weeks for long-term placement
 - Updates on data given to home-school SIT
- Transitions back to Home School
 - General Ed students will have progress reviewed by CIL Transition Team
 - SPED students will have transition plan worked out with their IEP team
 - Follow-up through home-school SIT
 - Follow-up if student has a Therapeutic or School-Based Counselor
