### SUBJECT:

Policy GCLE Unencumbered Time, First Reading

### BACKGROUND INFORMATION:

In 2023, S.C. Code Section 59-5-63 was enacted, which stated the following: “the district will require the principal of each elementary school to provide at least 30 minutes of unencumbered time on each regular school day to all full-time teachers teaching in grades kindergarten through fifth grade; and require the principal of each elementary, middle, or high school, to provide at least 30 minutes of unencumbered time on each regular school day to any full-time teacher who is responsible for instructing a special education class for more than 20 percent of the school day with students who are removed from the general education setting.” In 2024, the policy was updated to include school nurses and 4K teachers, “where practical.”

The State Board of Education (SBE) updated the statewide policy regarding unencumbered time to include school nurses on August 5, 2025. This change was made due to the requirements of proviso 1.111(SDE: School Nurses Unencumbered Time) in this year’s General Appropriations Act, below.

*1.105. (SDE: School Nurses Unencumbered Time) Of the funds appropriated through the Department of Education for school districts, the department shall work with school districts to incorporate, where practical, school nurses into the statewide policy outlining penalties and exceptions to the unencumbered time requirements pursuant to Section 59-5-63.*

### ADMINISTRATIVE CONSIDERATION:

Where practical, school nurses should receive 30 minutes of unencumbered time during the school day in addition to full-time elementary teachers and special education teachers that meet the criteria.

# UNENCUMBERED TIME

Code **GCLE** Issued **10/24/25**

In accordance with S.C. Code Section 59-5-63, the district will require the principal of each elementary school to provide at least 30 minutes of unencumbered time on each regular school day to all full-time teachers teaching in grades kindergarten through fifth grade; and require the principal of each elementary, middle, or high school, to provide at least 30 minutes of unencumbered time on each regular school day to any full-time teacher who is responsible for instructing a special education class for more than 20 percent of the school day with students who are removed from the general education setting. The District encourages including school nurses and 4K teachers in the unencumbered time requirements, where practical. The District will incorporate, where practical, school nurses in the unencumbered time and encourages, where practical, 4K teachers in the unencumbered time requirements.

## Procedure on How to Implement Unencumbered Time

*Unencumbered time* is defined as 30 minutes during the regular school day where teachers and school nurses are afforded time that is self directed without assigned duties or responsibilities, including direct instruction or supervision of students.

The placement of unencumbered time within the regular school day is flexible based on the staffing and scheduling needs of each school.

The unencumbered 30 minutes must not include parent/teacher conferences, bus duty, IEP and 504 meetings, team meetings, or professional development activities that are not self-directed. Also, the unencumbered time must not include managing or supervising the transition of students to and from activities, classes, lunch, recess, or any other activities

The provision of 30 minutes of unencumbered time must not be achieved by expanding the expected work hours for teachers before or after the school day.

Leadership may only withhold or reduce a teacher's unencumbered time in a given school day as a result of extreme or unavoidable circumstances. Such circumstances could include, but are not limited to, an emergency drill or an insufficient number of staff and substitute teachers to maintain instruction in the school. Additional compensation may not be offered in place of unencumbered time, except as provided by Section 59-5-63 (A)(2)(c).

The intentional failure of the school's principal to provide eligible teachers and school nurses with 30 minutes of unencumbered time may result in appropriate action under the district's disciplinary policy and may be sufficient cause for the suspension or revocation of such person's educator certificate pursuant to Section 59-25-160.

The intentional failure of the local school board to provide eligible teachers and school nurses with the required 30 minutes of unencumbered time may subject the board to any penalties prescribed by law.
