PROGRESS SUMMARY:

The contractor commenced operations on site on June 1. The Final Inspection with the Office of School Facilities is scheduled for January 9, 2013.

PROJECT SCHEDULE: As of January 1, 2013

 Contract date for Substantial Completion: December 20, 2012
 Scheduled date of OSF Final Inspection: January 9, 2013

The Contract Time has expired. The construction progress slowed considerably as the project neared completion. The remote site, small footprint, and small material quantities involved made it difficult for the contractor to schedule work by more than one trade at a time. If substantial completion is achieved with the OSF Final Inspection, the Contract Time will be exceeded by 20 calendar days. The Owner-Contractor Agreement has a liquidated damages clause of \$500 per day.
