## SUBJECT:

#### BACKGROUND INFORMATION:

Blackboard Inc. supports the District's web hosting service and parental notification systems; specifically, Web Community Manager, Mass Notification, Mobile Communications and Social Media Manager. The contract was initially awarded Blackboard Inc. in 2010.

## **ADMINISTRATIVE CONSIDERATION:**

The Procurement Code mandates that Board approval is required for any contracts beyond the year seven (7). The Communications Department wishes to continue these services through Blackboard Inc. and sees it to be in the best interest of the District to continue with this contract. Approval for a five-year period would alleviate the need to appeal to the Board every year for approval, though we would have the option not to renew at the end of each year.
