SUBJECT:

Construction Bids for the 2018 Scrubbing, Sanding, & Coating of Gymnasium Floors District Wide for Aiken County Public Schools

BACKGROUND INFORMATION:

- Bids were received for the 2018 Scrubbing, Sanding, Coating of Gymnasium Floors District Wide on April 10, 2018 at 2:00 p.m. and publicly opened. There were 4 bidders with Royalwood Associates, Inc. submitting the lowest responsible and responsive bid in the amount of (\$20,514.00) for Base Bid A; (\$10,270.00) for Base Bid B; and (\$9,286.00) for Base Bid D for a subtotal of \$40,070.00. The Flooring Connection, LLC. submitting the lowest responsible and responsive bid in the amount of (\$57,861.50) for Base Bid C. Total project cost would be \$97,931.50. The Five Year Facility Improvement Plan for 2018-2019 has the funds needed to complete these projects.

• ADMINISTRATIVE CONSIDERATION:

- The administration has reviewed the bids and determined that Royalwood Associates, Inc. is the most responsible and responsive bidder for Base Bid A (\$20,514.00) to scrub and coat gym floors at Jefferson Elementary, RS-M Elementary, Aiken Middle, A.L. Corbett Middle, Jackson Middle, Kennedy Middle, Leavelle McCampbell Middle, New Ellenton Middle, North Augusta Middle, Paul Knox Middle, Schofield Middle & Wagener-Salley High. Base Bid B (\$10,270.00) to scrub and coat gym floors at Aiken High, RS-M High & South Aiken High. Base Bid D (\$9,286.00) to scrub and coat of the stage floor, ramps and steps @ Jefferson Elementary, RS-M Elementary, Aiken Middle, A.L. Corbett Middle, Kennedy Middle, North Augusta High, Silver Bluff High, South Aiken High & Wagener-Salley High. The Flooring Connection, LLC is the most responsible and responsive bidder for (\$57,861.50) Base Bid C to sand, strip, painting & coating of gym floors at Midland Valley High, North Augusta High, & Silver Bluff High.

RECOMMENDATION:

- Authorize the administration to accept the bids and enter into a contract with Royalwood Associates, Inc. in the amount of \$40,070.00 for the 2018 Scrubbing & Recoating of Gymnasium Floors District Wide for Aiken County Public Schools.
- Authorize the administration to accept the bid and enter into a contract with The Flooring Connection, LLC. in the amount of \$57,861.50 for the 2018 Sanding, striping, painting and coating of Gymnasium Floors at Midland Valley High, North Augusta High and Silver Bluff High .
- Funding coming from the 2018-2019 Five-Year Facility Improvement Plan Gym Floors Budget.
