The Town of Monetta (Town) is proposing to install an elevated tank on or near the Ridge Spring – Monetta K5 through 12 School Campus at 10 JP Kneece Drive, Monetta, SC 29105. The Town is in the process of preparing and submitting a Community Development Block Grant to fund the construction of the proposed tank. 


