SUBJECT:

Items to be declared surplus and method of disposal – electronics equipment

BACKGROUND INFORMATION:

Electronic equipment has been determined to be obsolete and is no longer of use to the District. In accordance with the ACPSD Procurement Regulation XXVII,C,1: Surplus Management, Board approval is required for the disposal of any screened surplus items. These items have been screened and are no longer of use to the District.

ADMINISTRATIVE CONSIDERATION:

The Procurement Code mandates that Board approval is required to declare any District property surplus. The disposal of declared surplus items must also be approved by the Board. The District has awarded the most recent contracts for E-Waste to the vendor that holds the SC Statewide Contract for electronic recycling.

The Procurement Code directs that all monies received from the sale of District equipment and supplies shall be deposited in the general fund of the District.

RECOMMENDATION:

Authorize the Administration to dispose of electronic surplus items (E-Waste) by utilizing the SC State Contract (4400012206) for Electronic Recycling.
