SUBJECT:

BACKGROUND INFORMATION:

Section 642 of the Head Start Act requires grant agencies to establish and maintain a formal structure for program governance, including a policy council to advise on program operation and design and assist in the development of long and short-term planning goals and objectives. The policy council bylaws require the governing body to approve the membership of the policy council. The school board approved policy council candidates proposed on December 8, 2020. As additional candidates are nominated by Head Start / Early Head Start locations and communities, those will be presented to the school board for approval.
