#### SUBJECT:

Changes to Policy DD Funding Proposals, Grants, Special Projects – First Reading

#### **BACKGROUND:**

According to current policy the administration of grants and donations of \$1,000 or less is the responsibility of the assistant superintendent for area administration.

#### **ADMINISTRATIVE CONSIDERATION:**

The updated policy leaves all approvals based on grant and donation thresholds in place, but assigns administrative responsibility for grants and donations of \$1,000 or less to the school principal.

# FUNDING PROPOSALS, GRANTS AND SPECIAL PROJECTS

Code DD Issued 6/09

Purpose: To establish the basic structure for the accepting of additional sources of revenue for the district.

In order to offer the best educational opportunities possible for students of the district, the district will seek as many sources of revenue as possible to supplement the funds provided through local taxation and the basic aid offered by the state.

#### Grant awards

The district will may request and accept grants from federal, state, corporate and private sources.

The superintendent will seek approval from the board, prior to submission, of <u>for</u> grant applications in excess of \$10,000. The board will approve all grant awards in excess of \$1,000 before they are implemented.

Grants of \$1,000 or less will be approved by the area advisory council, administered by the assistant superintendent for area administration school principal and used in keeping with the terms of the grant.

### **Donations from private sources**

The district will may accept donations of money, securities, property, etc., from private sources for scholarships, staff development and other educational improvement purposes.

Donations in excess of \$1,000 will be approved by the board, administered by the superintendent and used in keeping with the terms of the donation. Exceptions to the board approval requirement will be donations received by the school from the school's Parent Teacher Organization (PTO) or other school-support organizations.

Donations of \$1,000 or less will be approved by the area advisory council, administered by the assistant superintendent for area administration school principal and used in keeping with the terms of the donation.

The board will not accept bequests, endowments or other donations if the conditions of the donation remove any portion of the public schools from control of the board or the advisory council.
