SUBJECT:

Monthly Financial Report for the Period Ended February 28, 2025

BACKGROUND INFORMATION:

The Business Services Department submits monthly financials for Board review, consideration, and acceptance.

ADMINISTRATIVE CONSIDERATION:

A breakdown of General Fund revenue and expenditures is presented for review. The attached report reflects budgeted amounts, current and year-to-date amounts, and the remaining balance. Revenue and expenditures through February 28, 2025, comprised 65% and 58%, respectively, of annual budget amounts. These percentages are in line with normal expectations through that time of year.

The packet also includes final information on 1% Education Capital Improvement Sales & Use Tax collections (reflecting the current and two previous years), as February 28, 2025, officially ended collection of the 2014 sales tax. Over its 10-year life, the 2014 sales tax generated \$231,711,274 and exceeded original projections by more than \$43 million.
