SUBJECT:

Monthly Financial Report for the Period Ended December 31, 2021

BACKGROUND INFORMATION:

The Business Services department submits monthly financials for Board review, consideration, and acceptance.

ADMINISTRATIVE CONSIDERATION:

A breakdown of General Fund revenue and expenditures are presented for review. The attached report reflects budgeted amounts, current and year-to-date amounts, and the remaining balance. Revenue and expenditures through December 31, 2021, comprised 43% and 46%, respectively, of annual budget amounts. As expected for this time of the year, expenditures outpace revenue as the District awaits a large influx of property tax revenue in January.

The packet also includes monthly and aggregate 1% Education Capital Improvement Sales & Use tax collections (reflecting the current and two previous years). Sales tax collections continue to outpace the year's projections of \$19,846,814.
