#### SUBJECT:

#### **BACKGROUND INFORMATION:**

The South Carolina Department of Education requires school board action when the determination of a school closure is made. The Superintendent has received school closure notification for Lloyd-Kennedy Charter School (June 30, 2021) and Aiken Performing Arts Academy Charter School (June 30, 2019). Notification of the closure of Aiken Performing Arts Academy Charter School was received on April 14, 2019, but school board action was not taken.

# RE: APAA Notice of Closure

The purpose of this correspondence is to provide written notification to the Consolidated School District of Aiken County that the Aiken Performing Arts Academy's (APAA) will close on June 30, 2019.

In past conversations and communications with the District Superintendent, Dr. Alford, I disclosed the charter high school would close after the completion of our 2018-2019 school term. The APAA has been working with our Attorney, David Pagliarini, and Executive Board Members to that end; focused on helping our students, families and staff with the transition.

The impending closure is the result of a personal health crisis which prohibited me from working at the same level I had in previous years. Unfortunately, during my absences, student enrollment and retention saw a marked decline. The financial impact associated with our small student count resulted in a grave operating situation for the APAA. To compensate for the loss in revenue the APAA contingency savings were used. This was done in hopes student enrollment would increase before the 45<sup>th</sup> Day Report, thereby increasing our revenue. However, the APAA did not see a significant increase in enrollment and our monthly income saw an additional decrease in December 2018.

It was at this time I began communicating with the APAA Board President, Dr. Alford and Mr. Pagliarini, about our financial situation. At the same time, with our savings depleting, the APAA Accountant, Ms. Mulrain, and I came up with a second financial plan using funds from the school's reserve account to complete the school year. But on February 19<sup>th</sup> CPA, Nicole Hillman, informed us our financial plan was not viable as it would require the use of restricted funds allocated for the USDA loan.

This new information resulted in an Emergency APAA Board Meeting, so Board Members could vote on a Revised Financial Plan that did not require the use of restricted funds. This plan was approved by the Board and contained revisions meant to ensure the APAA remained in operation for the remainder of this school year. What the financial plan did not do was give the APAA financial solvency for future years. Since S.C. Charter School Law requires existing charters to prove financial viability, the APAA cannot remain open beyond this fiscal year without major

changes that would greatly impact our mission. So, in keeping with this law, the Board also made the official determination to close the APAA on June 30, 2019 in a unanimous vote.

As the Founder and Director of the school, please know I am committed to working with School District Administrators to ensure a smooth closure. Additionally, Mr. Pagliarini may submit his own correspondence to the School District. It has been my privilege to operate the only performing arts high school in Aiken County. I look forward to focusing all future efforts on the Lloyd Kennedy Charter School (LKCS).

The LKCS Guidance Counselor, Aubrey Pompey, and Educational Consultant, Brenda Lloyd, will work with District designees to turn over records.

The LKCS will continue to follow its Academic Plan for this school year with the assistance of our SDE Coach, Patricia Woods, to ensure implementation and consistency. Although I am dealing with health limitations, I am happy to work with District designees during this transition.
