Revisions to All Levels

- Updated Cell Phone Policy. Board Approved in February to add Smartwatches to the policy. *A violation is the activation on school grounds during the school day of any paging device, cell phone, or any other personal electronic device, including smartwatches, except as authorized by this policy.*
- Dress Code – Under Appropriate Attire - *Leggings/tights/thermal tights may only be worn under dresses, shirts, or skirts of the appropriate length described above.*
LEGGINGS OR TIGHTS MAY ALSO BE WORN UNDER JEANS THAT HAVE HOLES TO COVER SKIN.
- Dress Code – Under Inappropriate Attire - *Garments that have open holes higher than the knee, **UNLESS TIGHTS ARE WORN UNDER THEM, COVERING SKIN***



Revisions to All Levels

- ▶ **Policy ADD Face Covering** – added the whole policy
- ▶ **Aiken Innovate Program** – added the addendum about virtual learning



Elementary Revisions

- ▶ Procedures for Administrative Placement at the Elementary Social Emotional Learning Program (XSEL).
- ▶ In certain circumstances, a principal may decide to recommend a temporary placement at the Elementary Social Emotional Learning Program (XSEL) due to a student's behaviors that cannot be corrected at the school level. After documented interventions at the school level, a principal may request placement at XSEL (through an Elementary Executive Director) after meeting with the student and parent to discuss this option. This referral does not require a disciplinary hearing with the HO as it is a continued intervention rather than a disciplinary placement.



Elementary - Continued

- ▶ Level III - Use of/Possession/Possession with intent to distribute/Selling illegal drugs, prescription drugs, or alcoholic beverage, including paraphernalia/ facsimile (materials passed as illegal drugs) and *CBD oils and materials*
