SUBJECT:

New Proposed Plan for Single Member Districts

BACKGROUND:

After census, governmental entities with Single Member District plans have to be reviewed and adjusted in order to equalize (within permissible deviation range) the populations of the Districts in order to comply with Department of Justice standards.

ADMINISTRATIVE CONSIDERATION:

Since 1987 the School District has had a Single Member District plan, and the plan has undergone adjustments (put into Legislation) by the Division of Research and Statistics [of the Budget and Control Board] in the early 90's, the early 2000's, and now for the most recent census. The attached map and statistical data is recommended by the Division and would meet all federal and state criteria in their opinion. The Division of Research and Statistics would like to get the Board's consensus or approval on this plan in order to meet the legislation and submit it to the Department of Justice for pre-clearance.

RECOMMENDATION:

Approve this plan so that the Legislative Amendments can be finalized.

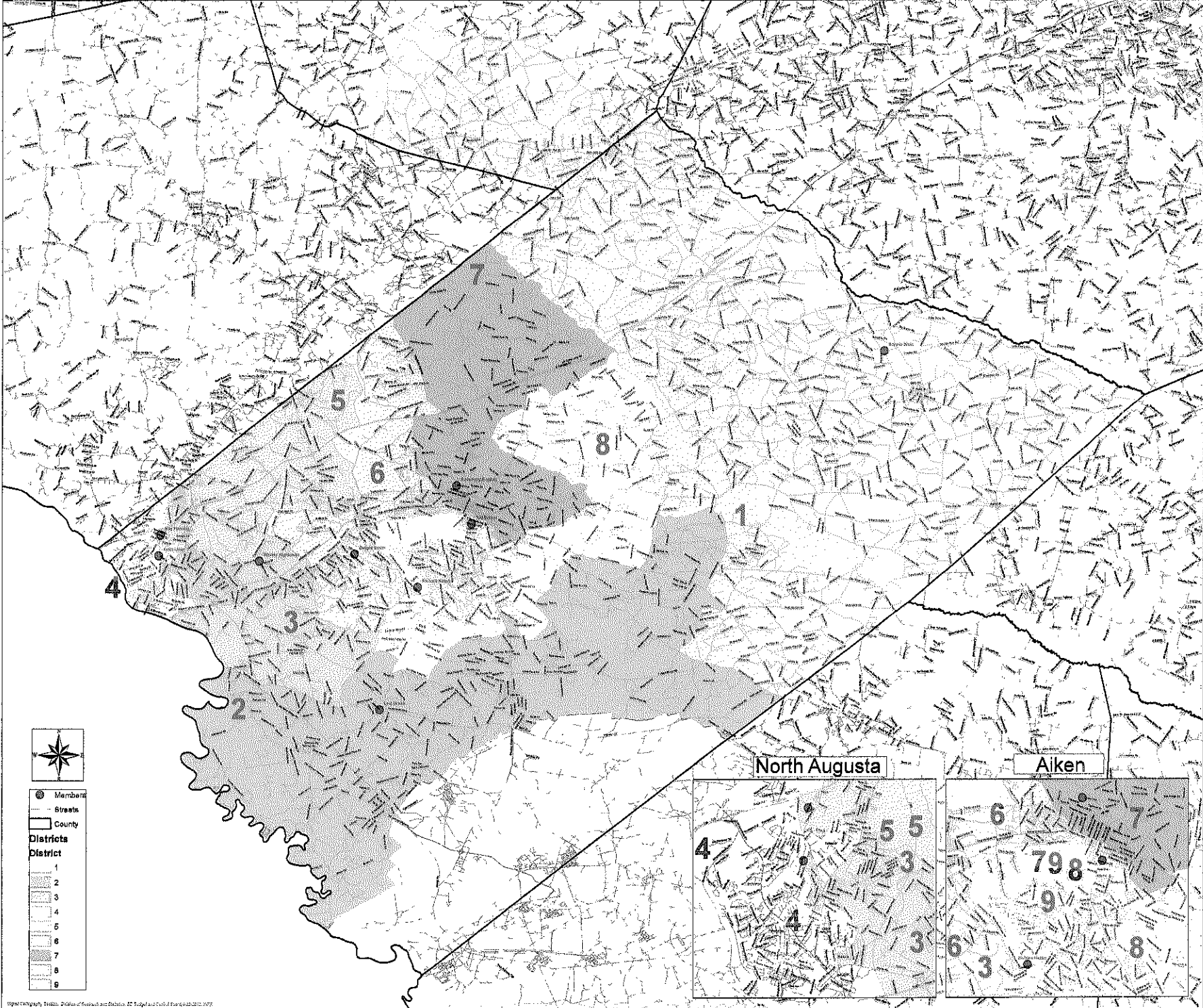
