In accordance with Policy FB, Facilities Planning, each year the Board of Education will review the Five-Year Facility Improvement Plan.

3. Aiken County Public School District (ACPSD) Underperforming Schools' Turnaround Plans Approval and Submission – 2024-2025 School Year (Dr. Edwards)

In accordance with S.C. Code Ann. 59-18-1624 (B)(1). For all underperforming schools, the district is required to consult with school and community stakeholders to review and revise the schools' and district's strategic plans with the assistance of their School Improvement Council, to include a turnaround plan component (Continuous Improvement Plan). The turnaround plan must include input from the community and must be approved by the local school board and then submitted to the SCDE Office of School Transformation for approval.

- 1. Ratification of Expulsions (Dr. Murphy)

The School Board, according to the Code of Laws for South Carolina Section <u>59-63-240</u>, is authorized to expel students from school. Although the Board may receive recommendations for expulsion from others, it is solely empowered to take the final expulsion action.
