New Ellenton STEAM Middle School was awarded \$3,764.00 from the Fuel Up to Play 60 Grant. This is a two-part grant. The Healthy Eating part of the award is focused on reducing food waste and \$2,764.00 will be used to purchase bins, signage and items for composting. The Physical Activity part of the award is to focus on walking activities and \$1,000.00 will be used to create a walking club at the school.

6. School Food Services Fuel Up to Play 60 Grant Award to Ridge Spring-Monetta Elementary School – FY21 (Mr. Traxler)

Ridge Spring-Monetta Elementary School was awarded \$3,286.00 from the Fuel Up to Play 60 Grant. This is a two-part grant. The Healthy Eating part of the award is focused on reducing food waste and \$2,826.00 will be used to purchase bins, signage and items for composting. The Physical Activity part of the award is to focus on walking activities and \$1,000.00 will be used to create a walking club at the school.

7. School Food Services Fuel Up to Play 60 Grant Award to LBC Middle School – FY21 (Mr. Traxler)

Langley-Bath-Clearwater Middle School was awarded \$3,993.00 from the Fuel Up to Play 60 Grant. This is a two-part grant. The Healthy Eating part of the award is focused on reducing food waste and \$2,993.00 will be used to purchase bins, signage and items for composting. The Physical Activity part of the award is to focus on walking activities and \$1,000.00 will be used to create a walking club at the school.
