2. Request to Admit Foreign Exchange Student (Dr. Minolfo)

School Board Policy JFABB establishes guidelines for the admission of the exchange students to the high schools in the School District of Aiken County

3. Out-of-District Transfers Requests – Transfers Out 2024-2025 (Dr. Minolfo)

Board Policy JFABC allows the Aiken County Board of Education to arrange with other school districts for the interchange of students. The policy stipulates that when students transfer out of the District, "the School District of Aiken County shall assume no responsibility for tuition to the receiving district."

4. Local School Board Courses for 2024-2025 (Dr. Edwards)

The school board must approve locally designed courses annually.

5. Cedar Creek Ladies Club Donation Greendale Elementary School- FY24 (Dr. Edwards)

Greendale Elementary School has received a \$1,100.00 donation from the Cedar Creek Ladies Club. These funds support the Santa Books program that provides a book to every student at Christmas at Greendale Elementary. These funds will be used to purchase books for this program for the 2024-2025 school year.
