In accordance with Policy FB, Facilities Planning, each year the Board of Education will review the Five-Year Facility Improvement Plan. At the Review in May of 2022, it was requested that the specific uses of the monies be indicated for as many years out as possible.

The policy stipulates that when students transfer out of the District, "the School District of Aiken County shall assume no responsibility for tuition to the receiving district."

School Board Policy JFABB establishes guidelines for the admission of the exchange students to the high schools in the School District of Aiken County.
